

Untold Nauvoo Stories

The community of Nauvoo will host a variety of weekend activities in Nauvoo February 1-3 with the return of the Untold Nauvoo Stories Historical Symposium. The symposium has expanded and will include two evening keynote speakers and seeks to celebrate Nauvoo's history with presentations that explore less well-known topics. The event will be augmented by the re-enactment of the 1846 Exodus from Nauvoo to the Salt Lake Valley by members of the Church of Jesus Christ of Latter-day Saints. The purpose of these events is to enrich the understanding of the personalities, conditions, and social currents that converge in Nauvoo.

Registration and open house begins at 11:30 a.m., February 1 at the Joseph Smith Historic Site Visitors Center. Sessions will run from 1-2:15 p.m., 2:30-3:45 p.m., 4:00-5:15 p.m. each day. A banquet will beheld on Friday, 5:30 – 8:00 p.m., at Hotel Nauvoo with keynote speakers Kim and Brenda Logan who will present "The Baxter Family of Nauvoo." On Saturday, 5:30-7:30 p.m., there will be a catered meal at Nauvoo Pageant Headquarters. Free-will donations will benefit the Nauvoo Food Pantry. Keynote speakers Lach Mackay and Eugene Shurts will present "Nauviews." Exodus Commemoration

On Saturday, Feb. 2, 2019 at 10:00 am, we invite everyone to participate in an event in Historic Nauvoo to commemorate the 1846 Pioneer Exodus. This event commemorates the departure of the first group of Latter-day Saint residents from Nauvoo. Those early pioneers forged a trail across southern Iowa, Nebraska, Wyoming, and into Utah. That route, now an official route of the National Park Service, is known as the Historic Mormon Trail. The Exodus Commemoration will begin with a free continental breakfast at 10:00 am at the Family Living Center (White Street, between Main and Granger), followed by a walk down Parley Street to the edge of the Mississippi River. The parade will feature flags representing the nationalities of those who lived in Nauvoo in the 1840s. Participants may choose to wear a name tag to represent one of the original pioneers. At the Pioneer Memorial, which is at the edge of the Mississippi River, there will be a short commemoration program. This event is an opportunity for everyone to remember the heritage of this area. It's That Time Again

You might need assistance in filing that income tax return if you are 65 years of age or older and are single (or married, filing separately) (\$12,000) or if you are married, filing jointly, and both of you are over 65 (\$24,000) and make amounts as listed above in wages, interest, dividends, gambling winnings, IRA distributions, pensions, and/or social security benefits. (In 2018, Social Security benefits were only taxable if ½ of those benefits plus your gross income were more than \$15,000 (or \$32,000 if married and filing a joint return. No changes have been made as of yet.)

Medicare Advantage Programs

NOTE: A Medicare Advantage <u>**Disenrollment**</u> Period (MADP) is available from January 1 to February 14. This allows you to go back to Original Medicare **ONLY**.

New in 2019: There is a one-time change allowed during Medicare Advantage Open Enrollment Period (MADP), which starts January 1 and ends March 31. Coverage begins the first month after enrollment. You must already be enrolled in a Medicare Advantage (MA) Plan on January 1. You can switch to a different MA Plan with or without drug coverage. You can return to Original Medicare and enroll in Part D but cannot switch from one PDP to another. Note: The Medicare Advantage Open Enrollment Period doesn't provide a Guaranteed Issue Right for a Medigap policy. Questions? The Delta Queen, What a History!



In December, 2018, the 91-year-old *Delta Queen* officially became exempt from a 1966 law that requires vessels carrying overnight passengers to be constructed of noncombustible materials.

The ship's boilers were built in 1919 and were originally intended for a World War I vessel. Two of the boilers were put into the *Delta Queen* when she was built in 1927. The *Queen* first ferried cars, freight, and passengers between Sacramento and San Francisco, serving during World War II as a ferry boat, ferrying soldiers from the San Francisco doc to ships anchored in the harbor.

The *Delta Queen* was bought as war surplus by the Greene Line Steamers. The 285' x 60' vessel, which has accommodations for 176 passengers and a crew of 80 began offering overnight cruises in 1947.

Twenty years later Congress passed the Safety at Sea Act (1966), which aimed to prevent fires aboard wooden, foreign-flagged passenger vessels calling on U. S. ports. The legislation's language, however, inadvertently applied to the *Queen*. Though her hull is made of steel, her upper decks are wooden.

Two-year intermittent exemptions were renewed until 2008, when Congress failed to take up the measure. The *Delta Queen* was docked in Chattanooga, Tennessee, where it served as a dockside hotel.


In 2015, a reconstituted Delta Queen Steamboat Company bought and moved her to Houma, Louisiana, where she now awaits her next job for the 10-year exemption (until 2028). The company is anticipating a \$10 million to \$12 million repair and refurbishment project, with cruises estimated to begin again in 2020.
